The **Department of Social Services** intends to make the following changes to the South Dakota Medicaid State Plan concerning income standards for the Reasonable Classification of Children under age 21 effective January 1, 2014. The proposed State Plan Amendment (SPA) eliminates the income test for children who are in state custody or under state guardianship. The proposed amendment replaces Supplement 8a to Attachment 2.6, page 2. The Department estimates there will be no federal fiscal impact associated with this SPA. The **Department of Social Services** intends to make the following changes to the South Dakota Medicaid State Plan concerning the use of financial eligibility findings used to enroll children in Medicaid effective January 1, 2014. The proposed State Plan Amendment (SPA) allows the Department to simplify the Medicaid application and enrollment process by eliminating repetitive application questions and eligibility determinations for children enrolled in SNAP. The proposed amendment adds pages 11b, 11c, 11d, and 11e to Section 2 of the South Dakota Medicaid State Plan.
