NOTICE:

The **Department of Social Services** intends to make changes to the South Dakota Medicaid State Plan concerning implementation of an asset verification system effective October 1, 2016. Per the proposed State Plan Amendment (SPA) an asset verification system will be used in determining or re-determining Medicaid eligibility for Medicaid applicants and recipients receiving long term care services. The SPA adds Supplement 16 to Attachment 2.6-A of the South Dakota Medicaid State Plan. The department estimates the federal fiscal impact associated with this SPA to be \$35,500.00 in Federal Fiscal Year 2017 and \$35,500.00 in Federal Fiscal Year 2018. Copies of the proposed SPA pages are available at the Department of Social Services, Division of Medical Services.
