NOTICE OF PROPOSED RULES: (The date in parentheses is the date the rules were filed in the Legislative Research Council.)

Department of Agriculture: Division of Ag Development: (December 11, 2014) intends to amend Value Added Agribusiness Relending Program rules to enhance the definition of "Rural Area" and to increase the loan amount as a percent of total project costs. The general authority for these rules, as cited by the department, is SDCL § 1-16E-24.
