**NOTICE OF PROPOSED RULES:** (The date in parentheses is the date the rules were filed in the Legislative Research Council.)

**Department of Game, Fish and Parks:** (December 11, 2013) intends to amend Black Hills Bighorn Sheep Hunting Season rules to make the bighorn sheep auction tag valid only in Unit 2 and modify the current boundary description for Unit 1 to include only the geographic area of the Rapid Creek bighorn sheep sub-herd population. The general authority for these rules, as cited by the department, is SDCL § 41-2-18.

A public hearing will be held at the Holiday Inn Express, 110 East Stanley Road, Ft. Pierre, South Dakota, on January 9, 2014, at 2:00 p.m. (CST). Copies of the proposed rules may be obtained from and written comments sent to Jeffrey R. Vonk, Secretary, Foss Building, 523 East Capitol, Pierre, South Dakota 57501. Written comments must be received by and in the office of the Secretary of the Department of Game, Fish and Parks on or before 12:00 p.m. three (3) days prior to the date of the hearing to be included within the record of the public hearing and to be considered by the Commission.
