NOTICES OF PROPOSED RULES: (The date in parentheses is the date the rules were filed in the Legislative Research Council.)

Department of Labor: Division of Labor and Management: (December 10, 2007) is proposing to amend Appendix B to the Workers' Compensation Fee Schedule. The general authority for this rule, as cited by the department, is SDCL 62-7-8.

A public hearing will be held in the Kneip Building, Conference Room #1, 700 Governors Drive, Pierre, South Dakota, on January 11, 2008, at 10:00 a.m., CST. Copies of the proposed rule may be obtained without charge from and written comments sent to the South Dakota Department of Labor, Division of Labor and Management, Kneip Building, 700 Governors Drive, Pierre, South Dakota 57501. Material sent by mail must be received by January 21, 2008, to be considered. Persons who have special needs for which the division can make arrangements are asked to call (605) 773-3681 at least 48 hours before the hearing.

Department of Game, Fish and Parks: (December 21, 2007) intends to amend Hunter Safety Course rules to increase the amount allowed for reimbursement of expenses incurred by hunter safety course instructors from one dollar per student to three dollars per student and clarify that the amount so allowed is considered as being reimbursement of expenses rather than compensation for services; and amend Special Permits and Licenses to create a new chapter entitled Permit to Kill Non-game Birds and include a new administrative rule authorizing the department secretary to issue a

special permit which would allow a designated permittee to kill non-game birds which are a threat to the public health, safety and welfare, or are doing damage to property. The general authority for these rules, as cited by the department, is SDCL 41-2-18 and 41-7-2.

A public hearing will be held at the Holiday Inn Express, 110 E. Stanley Road (Hwy. 83 & Stanley Road), Ft. Pierre, South Dakota, on January 10, 2008, at 2:00 p.m. (CST). Copies of the proposed rules may be obtained from and written comments sent to Jeffrey R. Vonk, Secretary, Foss Building, 523 East Capitol Avenue, Pierre, South Dakota 57501. Written comments must be received by and in the office of the Secretary of the Department of Game, Fish and Parks on or before 12:00 Noon three (3) days prior to the date of the hearing to be included within the record of the public hearing and to be considered by the Commission. Comments may also be sent by E-mail to chuck.schlueter@state.sd.us. All written and E-mail comments must include the commenter's name and address. This hearing is being held in a physically accessible place. Persons who have special needs for which the department can make arrangements are asked to call (605) 773-3387 before the hearing.
