NOTICES OF PROPOSED RULES: (The date in parentheses is the date the rules were filed in the Legislative Research Council.)

Department of Game, Fish and Parks: (December 23, 2008) intends to amend a rule to increase boat license fees as follows: (1) for non-motorized boats over 12 feet and boats propelled solely by electric trolling motors – 1 year from \$10 to \$12.50, and 3 years from \$20 to \$25; (2) motorboats under 19 feet – 1 year from \$15 to \$20, and 3 years from \$40 to \$55; and (3) motorboats 19 feet and over – 1 year from \$30 to \$40, and 3 years from \$80 to \$110. The general authority for this rule, as cited by the department, is SDCL 32-3A-4 and 32-3A-11.

A public hearing will be held at the AmericInn, 312 Island Drive, Ft. Pierre, South Dakota, on January 21, 2009, at 2:00 p.m. (CST). Copies of the proposed rules may be obtained from and written comments sent to Jeffrey R. Vonk, Secretary, Foss Building, 523 East Capitol Avenue, Pierre, South Dakota 57501. Written comments must be received by and in the office of the Secretary of the Department of Game, Fish and Parks on or before 12:00 p.m. three (3)

days prior to the date of the hearing to be included within the record of the public hearing and to be considered by the Commission. Comments may also be sent by e-mail to chuck.schlueter@state.sd.us. All written and e-mail comments must include the commenter's name and address. This hearing is being held in a physically accessible place. Persons who have special needs for which the department can make arrangements are asked to call (605) 773-3387 before the hearing.
