AMENDMENT A

On page 3, line 5 of the printed bill, after "assault" insert ", as provided in § 22-18-1, if committed".

On page 3, line 9, after "assault" insert ", as provided in § 22-18-1.1, if committed".

AMENDMENT B

On page 10, delete lines 2 to 10, inclusive, and insert:

" Section 2. That § 22-22-19.1 be repealed.

~~22-22-19.1. Any person, fourteen years of age or older, who knowingly engages in sexual contact with another person, other than that person's spouse, if the other person is under the age of twenty-one and is within the degree of consanguinity or affinity within which marriages are by the laws of this state declared void pursuant to § 25-1-6, is guilty of a Class 5 felony. Notwithstanding § 23A-42-2 a charge brought pursuant to this section may be commenced at any time prior to the time the victim becomes age twenty-five or within seven years of the commission of the crime, whichever is longer."~~

On page 10, line 11, delete "and § 22-22-19.1".

On page 10, line 12, delete "sections" and insert "section".

AMENDMENT C

On page 19, delete lines 10 to 15, inclusive, and insert:

" Section 3. That § 22-30A-2.1 be amended to read as follows:

22-30A-2.1. If any person transfers property purchased at a public auction beyond the borders of this state without first either making full payment for the property or obtaining the written consent of the auctioneer to transfer the property out of state, a rebuttable presumption arises that the transfer was made with intent to defraud within the meaning of §§ 22-30A-1 and 22-30A-10 and that the person who is the purchaser and transferer has committed theft."
