2 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

3 Section 1. That § 13-53-6 be amended as follows:

4 13-53-6. The ~~board~~ Legislature shall ~~fix~~ approve all rates of tuition and ~~other fees~~ to be paid  
5 by students beginning with all rates assessed during state fiscal year 1999. The board may fix any  
6 other fees paid by students.
