SENATE APPROPRIATIONS COMMITTEE

Introduced by: The Committee on Appropriations at the request of the Board of Regents

1 FOR AN ACT ENTITLED, An Act to authorize the Board of Regents to expend higher
2 educational facilities funds to lease certain educational facilities.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

4 Section 1. That § 13-51-2 be amended to read as follows:

5 13-51-2. There is continued an educational facilities fund in the state treasury from which on
6 and after July 1, 1984, the Board of Regents may make expenditures, relating only to institutions
7 of higher education under its jurisdiction, to:

- 8 (1) Make ~~lease-purchase~~ lease payments to the South Dakota Building Authority for
9 projects authorized to be paid out of that fund by the Legislature;
- 10 (2) Maintain and repair existing facilities in amounts as may from time to time be
11 authorized by the Legislature; ~~and~~
- 12 (3) Make rent payments to other private or public parties for educational facilities
13 authorized by the committee created by § 4-8A-2 that the committee has determined
14 to be necessary to the proper and efficient delivery of instruction; and
- 15 (4) Build and equip new facilities as may from time to time be authorized by the

1 Legislature.

2 No funding may be provided in any year for subdivision (3) or (4) of this section until the
3 level of annual appropriations reaches three million dollars for subdivision (2) of this section.
4 Authorizations for new lease payments, new construction, reconstruction, and renovation are
5 restricted to and shall not exceed the amount of higher education facilities funds in excess of the
6 sum of existing lease payments to the South Dakota Building Authority plus three million dollars
7 for maintenance and repair.

8 Section 2. That § 13-51-1 be amended to read as follows:

9 13-51-1. The Board of Regents of this state is hereby expressly prohibited from erecting any
10 buildings or structures or maintaining and equipping such buildings, or making any lease or lease-
11 purchase payments for any purposes authorized in § 13-51-2 without the approval of the
12 Legislature first obtained.
