1 FOR AN ACT ENTITLED, An Act to revise and remove certain segments of the state trunk
2 highway system.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

4 Section 1. That § 31-4-211 be amended to read as follows:

5 31-4-211. The state trunk highway system includes the following in Pennington County:

6 From a point on U.S. Highway 16B northeast of Rapid City south of the north quarter corner
7 of section thirty-two, township two north, range eight east, northeasterly ~~via Box Elder to the~~
8 ~~end of the divided highway in Box Elder in section twenty, township two north, range nine east~~
9 to near the Elk Vale Road interchange on Interstate 90.

10 Section 2. That § 31-4-188 be repealed.

11 ~~31-4-188. The state trunk highway system includes the following in Union county:~~

12 ~~From a point on Interstate Highway 29 in North Sioux City in section fifteen, township~~
13 ~~eighty-nine north, range forty-eight west, thence northwest via North Sioux City and Jefferson~~
14 ~~to Interstate Highway 29 west of Jefferson near the northeast corner of section twenty-four,~~
15 ~~township ninety north, range forty-nine west.~~

1 Section 3. That § 31-4-231 be repealed.

2 ~~—31-4-231. The state trunk highway system includes the following in Fall River county:~~

3 ~~—From the west railroad right-of-way in the southwest quarter of section two, township ten~~
4 ~~south, range two east at the former site of Igloo, thence northeasterly to State Highway 471 in~~
5 ~~section one, township ten south, range two east.~~

6 Section 4. That § 31-4-238 be repealed.

7 ~~—31-4-238. The state trunk highway system includes the following in Pennington county:~~

8 ~~—From a point south of Interstate Highway 90 at New Underwood near the southeast corner~~
9 ~~of section thirty, township two north, range eleven east, thence north to Interstate Highway 90~~
10 ~~north of the southwest corner of section thirty, township two north, range eleven east.~~

11 Section 5. That § 31-4-239 be repealed.

12 ~~—31-4-239. The state trunk highway system includes the following in Pennington county:~~

13 ~~—From a point on State Highway 230 in Box Elder north of the southwest corner of section~~
14 ~~twenty, township two north, range nine east, thence north to Interstate Highway 90 near the~~
15 ~~west quarter corner of section twenty, township two north, range nine east.~~
