1 FOR AN ACT ENTITLED, An Act to repeal certain statutes concerning the confidentiality of
2 certain information resulting from the examination, investigation, or audit of private entities.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

4 Section 1. That § 1-27-29 be repealed.

5 ~~— 1-27-29. A state agency which is authorized by law to investigate, examine, or audit the~~
6 ~~papers, books, records, financial condition, or other information held by or concerning a private~~
7 ~~entity may not disclose that it is conducting such an investigation, examination, or audit, except~~
8 ~~as provided by §§ 1-27-28 to 1-27-32, inclusive.~~

9 Section 2. That § 1-27-30 be repealed.

10 ~~— 1-27-30. All information obtained from or concerning the private entity by the state agency~~
11 ~~as a result of such an investigation, examination, or audit is confidential, except as provided by~~
12 ~~§§ 1-27-28 to 1-27-32, inclusive.~~

13 Section 3. That § 1-27-31 be repealed.

14 ~~— 1-27-31. A state agency may not disclose that it is investigating, examining, or auditing a~~

1 ~~private entity, and may only disclose the information obtained from such an investigation,~~
2 ~~examination, or audit as follows:~~

3 ~~— (1) — To the private entity being investigated, examined, or audited;~~

4 ~~— (2) — To those persons whom the private entity has authorized in writing to receive such~~
5 ~~information;~~

6 ~~— (3) — To the officers, employees, or legal representatives of any other state agency which~~
7 ~~requests the information in writing for the purpose of investigating and enforcing civil~~
8 ~~or criminal matters. The written request will specify the particular information desired~~
9 ~~and the purpose for which the information is requested;~~

10 ~~— (4) — To any administrative or judicial body if the information is directly related to the~~
11 ~~resolution of an issue in the proceeding, or pursuant to an administrative or judicial~~
12 ~~order. However, no person may use a subpoena, discovery, or other applicable~~
13 ~~statutes to obtain such information;~~

14 ~~— (5) — To another state pursuant to an agreement between the State of South Dakota and~~
15 ~~the other state, but only if the other state agrees to keep the information confidential~~
16 ~~as set forth in §§ 1-27-28 to 1-27-32, inclusive;~~

17 ~~— (6) — To the attorney general, state's attorney, or any state, federal, or local law~~
18 ~~enforcement officer;~~

19 ~~— (7) — To a federal agency pursuant to the provisions of federal law;~~

20 ~~— (8) — To the extent necessary to submit any final reports or filings which are otherwise~~
21 ~~required by law to be prepared or filed;~~

22 ~~— (9) — For investigations to protect the natural resources of the state; or~~

23 ~~— (10) — To comply with federal law, rules, or program delegation requirements.~~

24 Section 4. That § 1-27-32 be repealed.

25 ~~— 1-27-32. Disclosure of information made confidential by §§ 1-27-28 to 1-27-32, inclusive,~~

1 except as provided in § 1-27-31, is a Class 6 felony.

2 Section 5. That § 1-27-28 be repealed.

3 ~~1-27-28. Terms used in §§ 1-27-29 to 1-27-32, inclusive, mean:~~

4 ~~(1) "Private entity," any person or entity that is not a public entity as defined by~~

5 ~~§ 3-21-1(2);~~

6 ~~(2) "State agency," each association, authority, board, commission, committee, council,~~

7 ~~department, division, state office, task force, and their officers, legal representatives,~~

8 ~~consultants, or other agents. The term does not include the Legislature, the Unified~~

9 ~~Judicial System, any law enforcement agency, or any unit of local government.~~
