1 FOR AN ACT ENTITLED, An Act to revise per diem for certain legislative committees and to
2 declare an emergency.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

4 Section 1. That section 30 of chapter 14 of the 2000 Session Laws be amended to read as
5 follows:

6 Section 30. All members of state boards, councils, commissions, and advisory bodies listed
7 in this section, or created by law during the Seventy-fifth and Seventy-sixth Legislative Sessions,
8 are entitled to reimbursement for allowable expenses as approved by the Board of Finance under
9 the provisions of chapter 3-9. The salary or per diem compensation for members of state boards,
10 councils, commissions, and advisory bodies for their work in actual performance of their duties
11 or responsibilities is as follows:

1 and the recommendations for each of the next two fiscal years. The appropriations committees
2 of the Legislature shall review the recommendations and include in a separate section of the
3 general appropriations act the salary or per diem compensation and allowable expense
4 reimbursement for each such body, based upon whether it be a management, policy making,
5 legislative or advisory body, and which shall constitute the salaries or per diem compensation and
6 allowable expense reimbursement increases for members of such bodies for the next two
7 succeeding fiscal years.

8 Section 4. That chapter 2-4 be amended by adding thereto a NEW SECTION to read as
9 follows:

10 The salary or per diem compensation for members of the Legislature serving on legislative
11 committees, boards, or commissions is equal to the rate set by § 2-4-2 (2).

12 Section 5. Whereas, this Act is necessary for the support of the state government and its
13 existing public institutions, an emergency is hereby declared to exist, and this Act shall be in full
14 force and effect from and after its passage and approval.
