1 FOR AN ACT ENTITLED, An Act to prohibit the display of social security numbers on driver
2 licenses or nondriver identification cards.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

4 Section 1. That chapter 32-12 be amended by adding thereto a NEW SECTION to read as
5 follows:

6 No driver license or nondriver identification card issued after June 30, 2005, may contain
7 the social security number of the licensee.

8 Section 2. That § 32-12-17.10 be amended to read as follows:

9 32-12-17.10. An operator's license, motorcycle operator's license, restricted minor's permit,
10 motorcycle restricted minor's permit, instruction permit, and motorcycle instruction permit shall
11 bear a distinguishing number assigned to the licensee, the full legal name or any name lawfully
12 taken, date of birth, residence address, an indication if the licensee is a donor pursuant to chapter
13 34-26, an indication if the licensee as has a living will pursuant to chapter 34-12D or a durable
14 power of attorney for health care pursuant to chapter 59-7, a color photo, and a brief description



1 of the licensee, and the licensee's signature. The department shall indicate upon each license the
 2 general class of vehicles that the licensee may drive. If a barcode, or other means by which
 3 information may be retrieved electronically, is placed on the license, the data field may contain
 4 the information printed on the license ~~and the licensee's encrypted social security number. No~~
 5 barcode, or other means by which information may be retrieved electronically, may contain the
 6 licensee's social security number.

7 Section 3. That § 32-12A-20 be amended to read as follows:

8 32-12A-20. The commercial driver license shall be marked "Commercial Driver License,"
 9 shall be, to the maximum extent practicable, tamper proof, and shall include the following
 10 information:

- 11 (1) The legal name, residential, and mailing addresses of the licensee;
- 12 (2) The licensee's color photograph;
- 13 (3) A physical description of the licensee, including sex, height, weight, and eye color;
- 14 (4) Date of birth;
- 15 (5) An indication if the licensee is a donor pursuant to chapter 34-26;
- 16 (6) ~~The licensee's social security number;~~
- 17 ~~—(7)—~~The licensee's signature;
- 18 ~~(8)(7)~~ The class of commercial motor vehicle or vehicles which the licensee is authorized
 19 to operate, including any endorsements or restrictions;
- 20 ~~(9)(8)~~ The name of this state; and
- 21 ~~(10)(9)~~ The dates between which the commercial driver license is valid.

22 Section 4. That chapter 32-12A be amended by adding thereto a NEW SECTION to read
 23 as follows:

24 No commercial driver license issued after June 30, 2005, may contain the licensee's social
