

AN ACT

ENTITLED, An Act to increase the previously enacted expenditure authority for certain approved construction projects and to declare an emergency.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

Section 1. That section 1 of chapter 110 of the 2005 Session Laws be amended to read as follows:

Section 1. It is in the public interest that the South Dakota Building Authority contract for the construction, completion, furnishing, equipping, and maintaining of, including heating, air conditioning, plumbing, water, sewer, electric facilities, sidewalks, parking, landscaping, architectural and engineering services, asbestos abatement, removal of existing roofing and structures, and such other services or actions as may be required to accomplish the projects enumerated in section 3 of this Act, all at the estimated cost of one hundred thirty million one hundred thousand dollars. The South Dakota Building Authority may finance up to sixty-five million one hundred thousand dollars of the construction costs through the issuance of revenue bonds, in accordance with this Act and chapter 5-12.

Section 2. That subdivision (5) of section 3 of chapter 110 of the 2005 Session Laws be amended to read as follows:

- (5) The Shepard Hall renovation, replacement, or expansion space at South Dakota State University in Brookings, South Dakota, for an estimated cost of fifty-one million dollars, of which no more than twenty-four million dollars may be financed through the issuance of revenue bonds;

Section 3. That subdivision (8) of section 3 of chapter 110 of the 2005 Session Laws be amended to read as follows:

- (8) The Slagle Hall renovation at the University of South Dakota in Vermillion, South

Dakota, for an estimated cost of eight million five hundred thousand dollars, of which no more than four million six hundred thousand dollars may be financed through the issuance of revenue bonds; and

Section 4. That subdivision (9) of section 3 of chapter 110 of the 2005 Session Laws be amended to read as follows:

- (9) The business school replacement at the University of South Dakota in Vermillion, South Dakota, for an estimated cost of twenty million five hundred thousand dollars, of which no more than five million four hundred thousand dollars may be financed through the issuance of revenue bonds.

Section 5. That subdivision (2) of section 4 of chapter 110 of the 2005 Session Laws be amended to read as follows:

- (2) The renovation of the Myklebust Recreational Center at the South Dakota School for the Deaf in Sioux Falls, South Dakota, for an estimated cost of eight hundred thirty-eight thousand one hundred ninety-two dollars, of which seven hundred eighty-eight thousand one hundred ninety-two dollars (\$788,192) are appropriated from other funds available to the School for the Deaf and fifty thousand dollars (\$50,000) are appropriated from moneys allocated to this project by the Bureau of Administration from the statewide maintenance and repair fund established in § 5-14-30.

Section 6. That section 8 of chapter 110 of the 2005 Session Laws be repealed.

Section 7. That chapter 110 of the 2005 Session Laws be amended by adding thereto a NEW SECTION to read as follows:

Section 13A. The Board of Regents shall account for each expenditure related to projects authorized in this Act on the state's central accounting system. Each project shall be accounted for and reported separately.

Section 8. Whereas, this Act is necessary for the support of the state government and its existing public institutions, an emergency is hereby declared to exist, and this Act shall be in full force and effect from and after its passage and approval.
