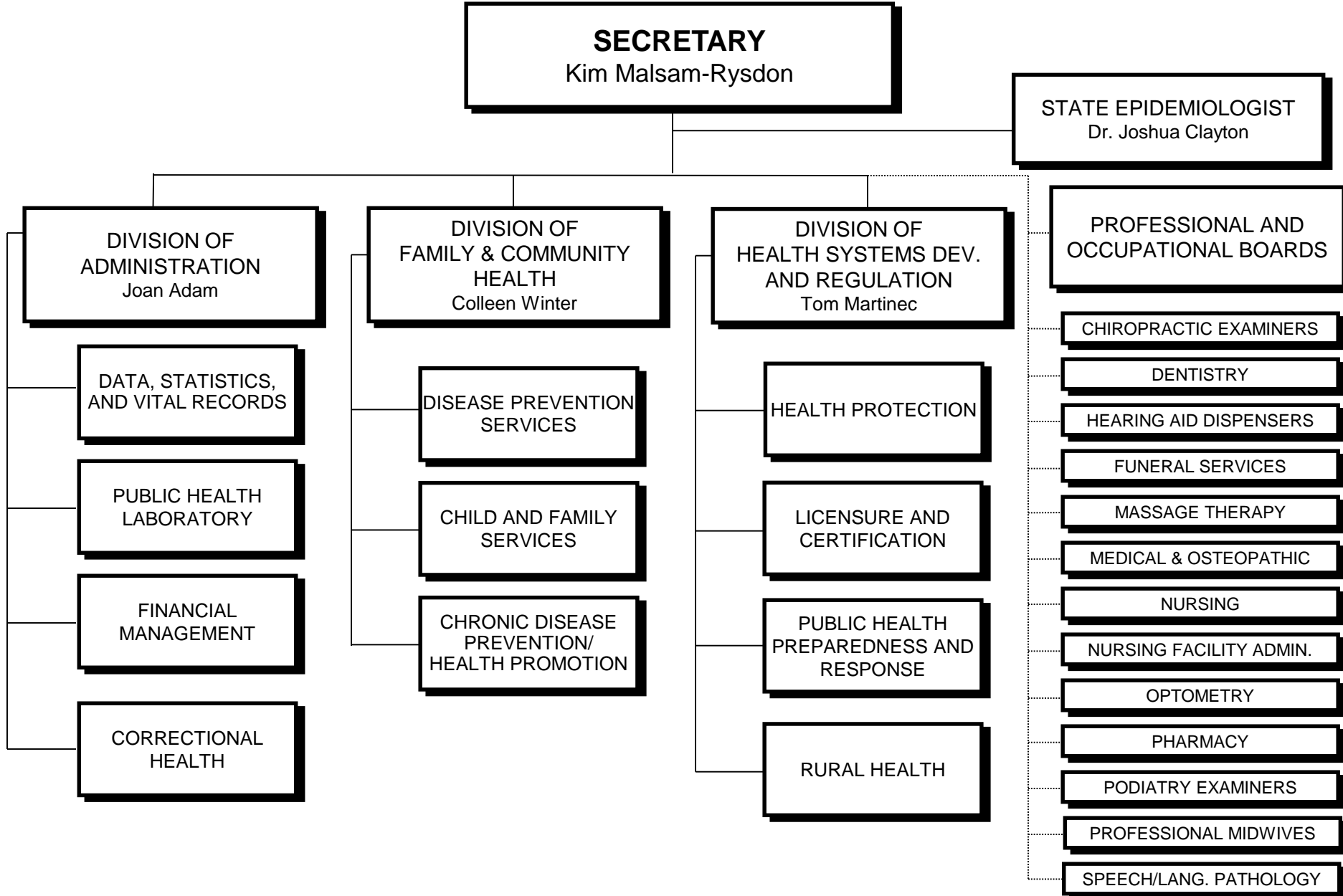

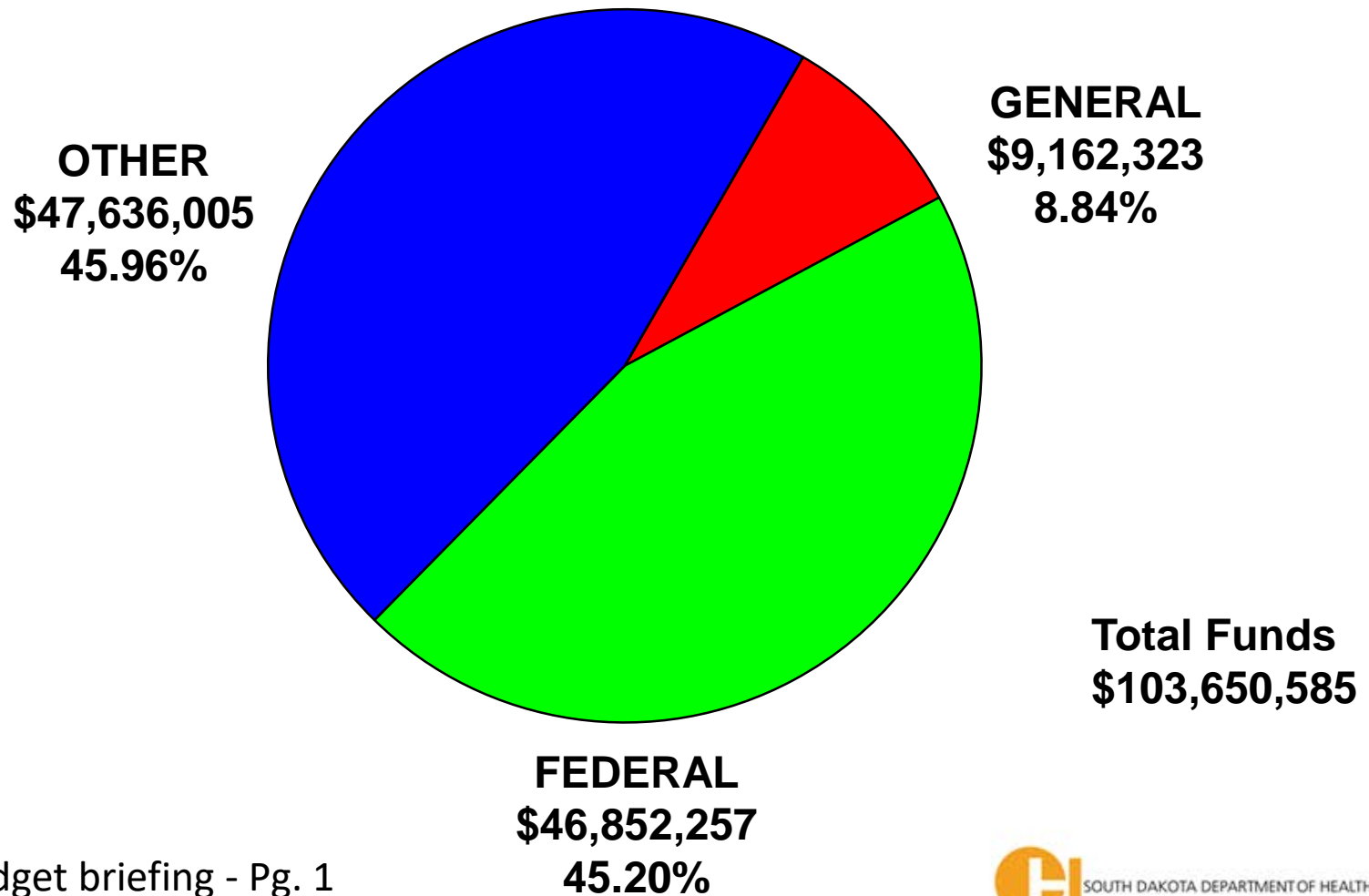
- ❖ 5 of the key performance indicators have more detailed information regarding significance of measure, SD/US rates and targets, and trend information

# All Divisions

## Various Programs

- Opioid Overdose Crisis Cooperative Agreement
- \$65,183 federal fund authority and 1.0 FTE in Family & Community Health
- \$2,448,900 federal fund authority
  - Funding split among all three divisions in the Department
  - Support development of clinical prescribing guidelines and provide trainings
  - Laboratory drug testing enhancement
  - Link data and patient information systems
  - Continue Naloxone distribution and training for EMS
  - Public awareness

# Health Systems Development & Regulation

## Rural Residency Program

- Expansion requested for year 2 of the residency track
- \$27,331 general funds, \$46,669 federal fund expenditure authority
  - 3 year ramp up- 2 students added each year
  - Year 2 has 4 students

# Special Appropriation

**An act to make an appropriation to reimburse certain health care professionals who have complied with the requirements for certain health care recruitment assistance programs and to declare an emergency.**

- Appropriates \$659,849 to reimburse four physicians, one dentist, and three physician assistants who will be fulfilling the requirements of their agreements with the State during FY 2020 and \$320,000 to reimburse 53 eligible healthcare professionals who have complied with the requirements of the Rural Healthcare Facility Recruitment Assistance Program in FY 2020.
