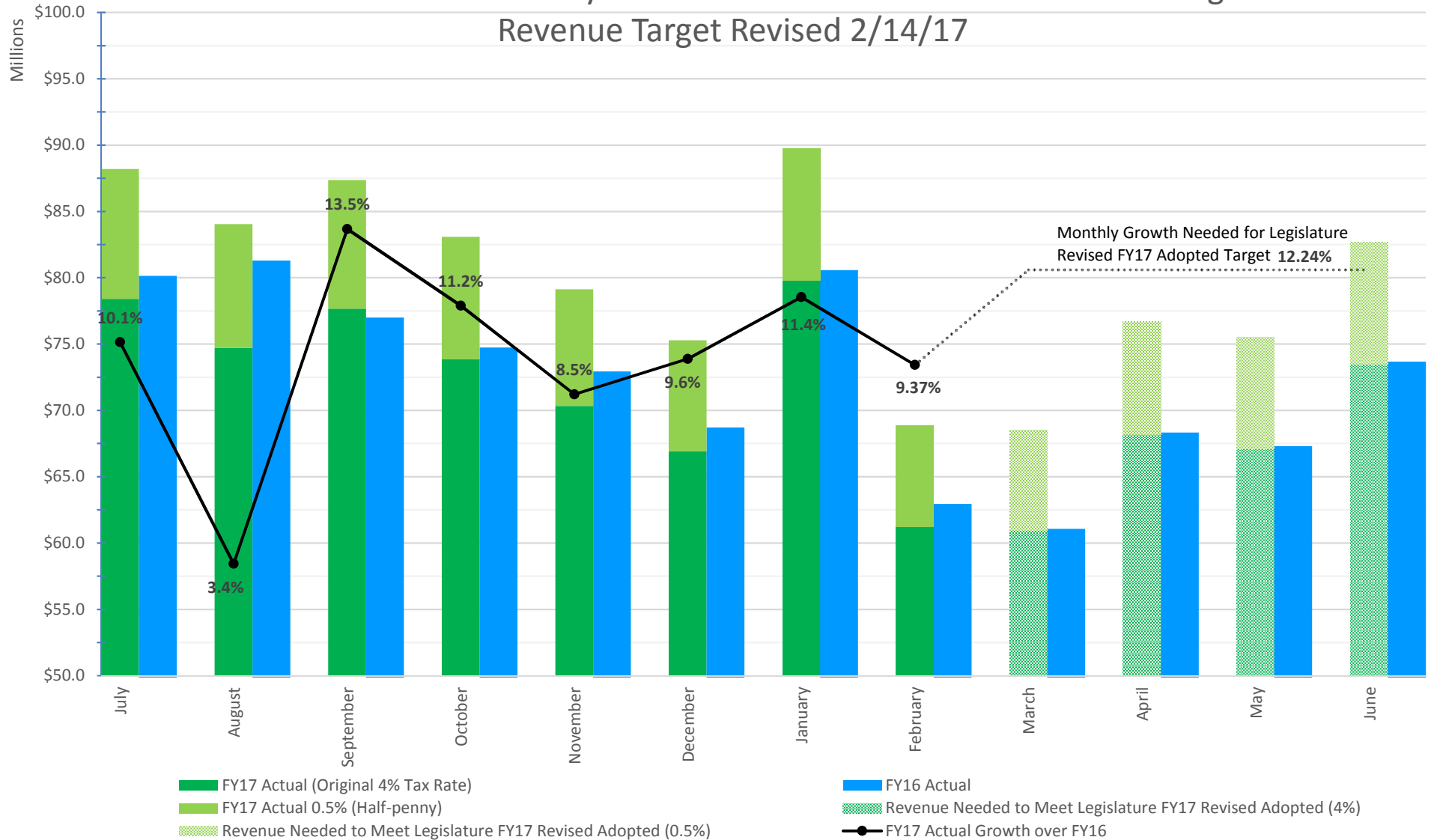

¹ **Sales and Use Tax** shows a postive variance of -\$2.9M from FY17 YTD target, which is 0.4% lower than the target; however the FY17 YTD is 9.6% higher than FY16 YTD. 12.5% of the increase can be attributed to the half cent increase making the year over year percent change from FY16 a negative 2.9%.

² **Unclaimed Property** shows a positive variance of \$810k from FY17 YTD target due to the Legislature adopting lower revised FY17 revenue and excludes \$7.52M in one-time unclaimed property from stock sales.
