To the Department of Game and Fish,  
of the State of South Dakota.

We, the undersigned owners of land under, adjoining and bordering upon that body of water in Spink county, South Dakota, known as Cotton-wood Lake, being desirous that such lake be kept up to a level where it may be maintained for the purpose of fishing and boating, and that the same may be stocked with fish, do hereby respectfully request that a dam be constructed by your department at the Outlet of said lake so as to raise the water thereof a distance of two feet from its present level at such outlet such expense to be borne by your department in connection with Spink County, and in consideration of the same we do hereby agree to consent to the construction of such dam and that we will not hold the State or County liable for such land or any portion thereof as may be flooded by reason of the raising of such waters and hereby release any such damage caused thereby.
