Federal Funding Summary

2020 CARES Act - Family Violence Prevention and Services

Overview

Provides funding to public or non-profit organizations to provide temporary housing, assistance and supportive services to victims of family, domestic, and dating violence in response to the COVID-19 public health emergency.

Period of Performance: March 27, 2020 – September 30, 2021

Allowable use of Funds:

- Activities that assist domestic violence survivors by providing supportive services, shelter options, and supplies which will reduce the exposure and risk of COVID-19.
- Activities that include assessing needs of survivors during the COVID-19 public health emergency. Activities that provide training, information and assistance necessary to ensure the continuity of domestic violence services

Award:

- The State was allocated funds of \$92,668
- There is no match requirement with this grant.
- Must issue supplemental sub-awards to local domestic violence programs within 60 days of receiving CARES Act Allocation.
- The state will retain 5% of the award to cover administrative costs and open up 80% of the remaining funds for subawards immediately. The remaining 20% would be retained for an estimated six-month period. This would allow for additional resources if needed, should new hot spots or situations develop after the initial awards.

2020 Emergency Management Performance Grant Program COVID-19 Supplemental (EMPG-S)

Overview

Provides funding to assist states, territories, tribes and local governments with their public health and emergency management activities supporting the prevention of, preparation for, and response to the ongoing Coronavirus Disease 2019 public health emergency.

Period of Performance: Jan. 27, 2020 – January 26, 2022

Project Period: 2 years

Award:

- The State was allocated funds of \$909,970

- This grant requires a 50% grant match; it currently has been approved that the State’s \$1.25 Billion received in CARES Act Funds could be used to cover the match requirement.

Status Update:

At this time the department hasn’t used any of this funding.

FY20 Coronavirus Emergency Supplemental Funding

Overview

Provides funding to assist eligible states, local units of government, and tribes in preventing, preparing for, and responding to the coronavirus.

Period of Performance: Jan. 20, 2020 – January 20, 2022

Project Period: 2 years, with the possibility of a 1-year extension

Eligibility

States, units of local government, and federally recognized tribal governments that were identified as eligible for funding under the FY2019 State and Local Edward Byrne Jag Grant.

- The State was funded \$3,291,196
- The following units of local governments/tribes can directly apply for an additional \$1,505,618.
The following are eligible for this additional funding:

- Funding may be used at the state level and we have the option to pass this through to local governments/tribes, but that is not required.
- Local units of government is defined as town, townships, village, parish, city, county, borough, or other general purpose political subdivision of a state, or federally recognized Indian tribal government that performs law enforcement functions.
- Local government may be any law enforcement district or judicial enforcement district established under applicable state law.

Allowable Projects and Purchases

Included but not limited to, overtime, equipment (including law enforcement and medical personal protective equipment), hiring, supplies (such as gloves, masks, sanitizer), training, travel expenses

(particularly related to the distribution of resources to the most impacted areas), and addressing the medical needs of inmates in state, local, and tribal prisons, jails, and detention centers.

Status Update:

At this time the grant was only opened up to the following 5 tribes that were not eligible to apply directly for CESF funds from DOJ:

- Lower Brule
- Sisseton/Wahpeton
- Flandreau
- Yankton Sioux
- Standing Rock

Lower Brule and Flandreau were the only tribes that took advantage of our solicitation at this time.
