Notice of Proposed Rules: (The date in parentheses is the date the rules were filed with the Legislative Research Council.)

Department of Transportation:

(January 7, 2019) intends to amend rules to extend the 55 miles per hour speed zone on State Trunk Highway 50 in and around Tyndall in a westerly direction; and establish procedures for the application and approval of loans to local government highway jurisdictions for the marking, constructing, reconstructing, repairing, and maintenance of highways and bridges of the state. The general authority for these rules, as cited by the department, is SDCL §§ 31-5-8 and 32-25-7.

A public hearing will be held in the Commission Room, Becker Hansen Building, 700 East Broadway Avenue, Pierre, South Dakota, on January 31, 2019, at 9:00 a.m. CT.
