**Notice of Proposed Rules:** (The date in parentheses is the date the rules were filed with the Legislative Research Council.)

**Department of Revenue: South Dakota Commission on Gaming:** (February 28, 2019) intends to amend rules to add a new variation of blackjack known as Blazing 7's Progressive, and increase players' chances of winning at the variation of blackjack known as Triple Win 20. The general authority for these rules, as cited by the commission, is SDCL §§ 42-7B-4 and 42-7B-7.
