### FILINGS IN THE LEGISLATIVE RESEARCH COUNCIL'S OFFICE:

**Notice of Proposed Rules:** (The date in parentheses is the date the rules were filed with the Legislative Research Council.)

**South Dakota Retirement System:** (March 8, 2019) intends to amend rules to update statutory citations of authority and internal cross references to correspond with the changes resulting from passage of House Bill 1010 of the 2019 Legislative Session, and to clarify language and repeal obsolete provisions. The general authority for these rules, as cited by the agency, is SDCL §§ 3-12C-202, 3-12C-211, 3-12C-214, 3-12C-711, 3-12C-801, 3-12C-1001, and 3-12C-1647.

A public hearing will be held at Drifters, 325 E. Hustan, Fort Pierre, South Dakota,
