NOTICES OF PROPOSED RULES: (The date in parentheses is the date the rules were filed in the Legislative Research Council.)

Department of Revenue and Regulation:
Division of Insurance: (March 30, 2009) intends to adopt EMERGENCY rules to implement special continuation rights for individuals in the State of South Dakota. The general authority for these rules, as cited by the division, is SDCL 58-18-79.

A copy of the proposed rules may be obtained from the South Dakota Division of Insurance, 445 East Capitol Avenue, Pierre, South Dakota 57501-1234.

Department of Social Services: (April 1, 2009) has filed a rule amendment to establish new parameters for the monthly gross and net income eligibility standards for food stamp households and to establish a household's maximum food stamp allotment based on the established thrifty food plan.

This rule is adopted under the procedure provided in SDCL 1-36-20. This procedure permits adoption of a federally mandated rule without following the procedures set forth in SDCL 1-26-4 to 1-26-6, inclusive.

Secretary of State: Board of Elections: (April 1, 2009) intends to amend rules to clarify the address which the voter registration address verification notice is mailed to and include information on how to handle the notice if that person is no longer residing at that address; amend language in the notice of election for special district formation to clarify when the trustee election will be held; amend the

municipal election ballot to include a list of the types of municipal governing boards; amend the certificate of nomination to fill vacancy form to include the principal residence address of the candidate; amend the approval of automatic tabulating system requirements for certification; amend the instructions to absentee voters to include instructions to not return the absentee ballot to the polling place; amend the type of seal used for sealing a ballot box; require the use of paper seals on the ballot box; amend the certification by precinct election board to include certification language for election boards which use electronic pollbooks; remove the date of the election from the official stamp for ballots; modify absentee ballot envelopes; repeal color requirement for special district ballots; add ballot format for special district formation elections; add ballot for school district reorganization elections; add ballot format for sanitary district elections; add petition form for establishing or eliminating school board representation areas; add petition form for referring the discontinuance of an attendance center; and put security measures in place for the use of electronic pollbooks. The general authority for these rules, as cited by the office, is SDCL 6-16-8, 12-1-9, 12-4-35, 12-17B-17, and 12-20-52.

A public hearing will be held on May 7, 2009, at 3:00 p.m. CST in Dakota Digital Network locations at the State Capitol, 500 E. Capitol Avenue, Room B12, Pierre, South Dakota 57501 and University of South Dakota State University, 2205 Career Place, University Center Building, Room 282, Sioux Falls, South Dakota 57107.
