NOTICES OF PROPOSED RULES: (The date in parentheses is the date the rules were filed in the Legislative Research Council.)

Department of Game, Fish and Parks:

(April 14, 2006) intends to amend Park Entrance License Exemptions – a park entrance license will not be required at Rocky Point Recreation Area on July 11, 2006, and on July 15, 2006; amend Restrictions on use of firearms and bow–Exceptions – possession of a bow at the Adams Homestead and Nature Preserve will be permitted during the archery deer season if the person has "any" type of archery deer licenses and a special permit each of which must be valid at the Preserve; amend Archery Antelope Hunting Season – establish the types of licenses/tags available and permitted harvest of antelope for each type of license; amend Archery Deer Hunting Season – modify the season dates in certain areas within the Black Hills; repeal the closure (hunting presently prohibited during the West River Prairie Deer Hunting Season) of the hunting season at the Fort Meade Bureau of Land Management South Unit and North Unit in Meade County; permit persons with certain types of archery deer licenses/tags and a special permit to hunt on the Adams Homestead and Nature Preserve and establish the number of licenses/permits available for issuance to hunt at the Preserve; and repeal the provision which presently prohibits nonresidents who have an "antlerless deer" license from hunting in the counties of Union, Lincoln, Minnehaha, and Moody; amend General Muzzleloading Deer Hunting Season – permit a person to acquire 2 muzzleloader deer licenses of any type; amend Youth Deer Season – modify (lengthen) the youth hunting season dates; amend Special Canada Goose Hunting Units Established—Limited permits—

Application – combine the 2 existing hunting Units in Bennett County into 1 Unit and establish the number of licenses available and hunting season dates; and amend Mountain Lion Hunting Season – modify the hunting season dates for the hunting season and establish the harvest limits for certain mountain lions and the restrictions/prohibitions applicable to harvesting a mountain lion in certain areas. The general authority for these rules, as cited by the department, is SDCL 41-2-18, 41-11-5, 41-17-1.1, and 41-17-13.4.

A public hearing will be held at the Radisson Hotel, 445 Mt. Rushmore Road, Rapid City, South Dakota, on May 4, 2006, at 2:00 p.m. Copies of the proposed rules may be obtained from and written comments sent to John L. Cooper, Secretary, Foss Building, 523 East Capitol Avenue, Pierre, South Dakota 57501. Written comments must be received by and in the office of the Secretary of the Department of Game, Fish and Parks on or before 12:00 Noon on the day prior to the date of the hearing to be included within the record of the public hearing and to be considered by the Commission. Comments may also be sent by e-mail to chuck.schlueter@state.sd.us. E-mail comments must include the commenter's name and address. This hearing is being held in a physically accessible place. Executive Orders:

The Governor has signed **Executive Order 2006-03** dated April 11, 2006. Under the authority of SDCL chapter 33-15, the Emergency Management Law, the Governor has granted authority to the Division of Wildland Fire Suppression to augment its response efforts with available assets of the South Dakota National Guard for the 2006 fire season of April 1 through October 31.

The Governor has signed **Executive Order 2006-04** on April 13, 2006. This order creates a tobacco-free environment on all property owned or leased by the State. It applies to all state employees, clients, visitors and other persons who may enter state property. The order allows certain exceptions for areas designated in the order and others designated by Secretary's of the Departments of Human Services, Military and Veterans Affairs, Game, Fish and Parks, and the Commissioner of the Bureau of Administration.
