NOTICE:

The **Department of Social Services** intends to make the following changes to the South Dakota Medicaid State Plan concerning the payment of telemedicine services effective October 1, 2014. The proposed State Plan Amendment (SPA) allows payment of a facility fee to eligible originating sites for completed telemedicine transactions. The proposed amendment revises page 6 of Attachment 4.19-B of the South Dakota Medicaid State Plan. The Department estimates there will be a federal fiscal impact of \$3,262.73 in FFY 2015 and \$3,262.73 in FFY 2016.
